

In order to address the issue of child protection, the Government of India is implementing the Juvenile Justice (Care and Protection of Children) Act, 2015 and Integrated Child Protection Scheme. These aim to build a safe environment for children in difficult circumstances. Capacity building of various functionaries and stakeholders is one of the key components of ICPS and JJ Act 2015.



CRC GENESIS


Ensuring child protection is responding to the problems of children in difficult circumstances and addressing their vulnerabilities so that they receive necessary care and protection. While protection is the right of every child some children are more vulnerable, and thus require special attention.

Addressing this state of affairs, the Integrated Child Protection Scheme (ICPS) was introduced by the Government of India in the year 2009. Recently, the Government of India re-named the ICPS as "Child Protection Services" (CPS) under the umbrella of Integrated Child Development Services (ICDS). Apart from this, the State Government implements the Juvenile Justice (Care and Protection of Children) Act, 2015, Protection of Children from Sexual Offences Act, 2012, Prohibition of Child Marriage Act, 2006 for the protection of children.

To enhance the capacities of different stakeholders, the Juvenile Justice (Care and Protection of Children) Act, 2015 and Model Rules, 2016 have made a provision of training of minimum of 15 days for various functionaries under JJ system Capacity building of the various functionaries is one of the key components of CPS. It emphasizes the building of capacities at all levels of service providers and places importance on developing technical expertise through training of personnel in the allied system of the departments concerned, and of various stakeholders to enable them to undertake responsibilities under CPS.

The Department for Child Rights (DCR) was created by the Government of Rajasthan to provide operational efficiency to the implementation of the then ICPS and now CPS and other child protection related programmes. Prior to setting up of Child Resource Centre (CRC), several gaps were identified in the effective implementation of capacity building component of the scheme. There was an absence of an apex institution that could build institutional capacities and prepare a pool of quality professionals and subject experts in the domain of child rights.

Against this backdrop, the Child Resource Centre (CRC) has been established in 2016, as a joint initiative of Rajasthan State Child Protection Society of the Department for Child Rights (DCR) and Harish Chandra Mathur Rajasthan State Institute of Public Administration (HCM RIPA) with technical support from UNICEF, Rajasthan and Antakshari Foundation. Child Resource Centre (CRC) is a strategic venture with focus on capacity building of all stakeholders in the child rights & protection systems and creation of knowledge hub for its ultimate vision of creating an enabling environment for children.

CHILD PROTECTION SUPPORT DESK

A Child Protection Support Desk (CPSD) has been set up at CRC, which focuses on catering to the needs and of field level functionaries on dealing with child protection cases and will provide them hand holding support through addressing their queries. The objective is to provide technical guidance and hand holding support to the authorities. The rationale regarding establishing Child Protection Support Desk was following:-

- # There has been an increasing concern about the need to extend care & protection to children who experience abuse, violence & exploitation.
- #Limited capacity of key individuals, authorities and institutions responsible for protecting and fulfilling the rights of children.
- # Challenges in documentation and case management due to inappropriate knowledge.
- #Limited understanding on related to judicial procedure.
- # Missing handholding mechanism for authorities.
- #Lack of pro active initiatives by authorities.

Child Protection Support Desk is a unique initiative of Antakshari Foundation with Child Resource Centre, Department for Child Rights and UNICEF and it was formally launched on 18th April 2017 by Madam Gurjot Kaur, Director General, HCM RIPA and Additional Chief Secretary, GOR.

The CPSD, within a year was able to provide hand-holding support and on-site trainings for following stakeholders. These training have enhanced the capacities of the stakeholders and strengthen their functioning. In the Year 2018–19, The Child Protection Support Desk, CRC has worked on mentoring support to key JJ Functionaries i.e. Child Welfare Committees, Special Juvenile Police Units, Govt. run Child Care Institutions and District Child Protection Units of selected districts of State.

A team of mentors identified by CPSD was responsible for mentoring support to CWCs, DCPUs, SJPUs and Govt. CCls of selected districts of Rajasthan including Bhilwara, Sawai Madhopur, Alwar, Jodhpur and Tonk. The mentors oriented and worked on the above mentioned authorities about the procedural and practical aspects on child related Acts and also strengthened the skills for Documentation and Case Management. They visited these authorities on selected days and provided mentoring and hand-holding support to them on identified key parameters and subjects.

Following are the achievements of Mentoring Work:

- # Proper utilization of forms has been done by CWCs, JJBs, SJPUs and CCIs.
- # The CWCs and CCIs have formed separate registered as per JJ Norms and update them on regular basis.
- # The Panel of Support Person under POCSO Act, and JJ Act has been prepared and the list of the same has been shared with CWC and DCPU.
- # The Daily Cause list has been followed both by CWC & JJB and has also been fixed outside the premises of CWC & JJB in 5 mentoring district.
- # The Duty Roster system has been duly followed by CWC and JJB as mandated in JJ Act and Model Rules.
- # Quarterly meeting has been organized regarding the preparation of District Child Protection Plan with relevant department.
- # After the mentoring of the JJ functionaries they are maintaining separate case files of each child produced before them and giving case numbers too.
- # Orders regarding the preparation of SIRs has now been initiated and prepared by the concerned person designated as mandated which earlier was not followed.
- # ICP of the children has also been prepared by the counsellors after training of CCIs by the mentors.



CAPACITY BUILDING

The components of training and capacity building of all stakeholders have been integrated in the Juvenile Justice (Care and Protection of Children) Act, 2015 making it mandatory for many key functionaries under the Act. The State government has been given the responsibility under the act for ensuring implementation of the said provisions through conducting effective trainings and capacity building programmes. Against this backdrop, the Child Resource Centre (CRC) has been established in 2016, as a strategic venture with focus on capacity building of all stakeholders in child rights & protection systems.

In line with this, the key mandate of CRC is to appraise the training needs of the various child rights stakeholders, design course curriculum and conducts capacity building programmes for various stakeholders on the subject of Child Rights & Protection. From the period of April 2018 to March 2019, CRC has conducted a total 26 capacity building programmes and workshops for child protection functionaries with support from UNICEF and Department for Child Rights, Rajasthan and a total 1073 personnel of child protection and Juvenile Justice Systems were trained through the same.

MAINSTREAMING CHILD RIGHTS AND PROTECTION: INTEGRATION IN TRAINING PROGRAMMES OF HCM

Capacity building of the various functionaries is one of the key components of ICPS and Juvenile Justice (Care and Protection of Children) Act, 2015. The second objective of ICPS is to enhance capacities at all levels, of all functionaries including, administrators and service providers, members of allied systems including, local bodies, police, judiciary and other departments concerned of State Governments to undertake responsibilities under the ICPS.

The components of training and capacity building of all stakeholders have been integrated in the Juvenile Justice (Care and Protection of Children) Act, 2015. The Rule 89 of the Model JJ Rule, 2016 specifically makes training of various stakeholders mandatory and specifies the training of personnel dealing with children. Child protection is an issue that spreads across various departments and sectors including Health, Medical, Education, Police, Judiciary, Panchayati Raj, Railway, Transport etc. Strong allied system is the key feature for ensuring child protection and strengthening systems across the country.

In view with this, mainstreaming of child rights and protection is one of the key objectives of the centre. CRC also aims to strengthen governance for children and it strives to inform, educate and empower arms of State government to mainstream child rights/child protection. The process has been initiated through ensuring trainings and sensitization sessions for all the government functionaries receiving trainings at HCM RIPA and till March 2019 there has been total 83 sessions conducted at HCM RIPA on subjects related to child Rights and protection in which around 2421 government officials have been oriented and sensitized on various topics related to child protection and Juvenile Justice including child rights and protection; an Introduction, Situation of children, child sexual abuse and Protection of Children form Sexual Offences Act, 2012 (POCSO), Trafficking of Children, Child At Risk, Situation of children during disasters, schemes and programme related to children etc. The trainees include Government functionaries like officers from Secretariat, Accounts, Education health, Women Empowerment, Police, Prosecution, Agriculture, Medical, Teachers, Principles/Lecturers, Civil Engineers, Youth Interns, and also Rajasthan Administrative Services, Probationers.

In the Year 2018-19 total 42 sessions conducted and total 1345 government personnel sensitized through the same as mentioned below:



CONSULTATION WITH DIFFERENT STAKEHOLDERS ON MAINSTREAMING CHILD RIGHTS

The components of training and capacity building of all stakeholders have been integrated in the Juvenile Justice (Care and Protection of Children) Act, 2015. The Rule 89 of the Model JJ Rule, 2016 specifically makes training of various stakeholders mandatory and specifies the training of personnel dealing with children. In line with the provisions there is a strong need for appropriate and adequate training programmes for child protection Stakeholders under the Juvenile justice system and other stakeholders directly or indirectly linked with the issues of child protection.

The general scenario of existing trainings has certain limitations and gaps as highlight below:

Absence of trainings and capacity building programmes for various stakeholders

#The scope of trainings is very limited

More theoretical aspects are covered than practical

#The quality of trainings has not been evaluated

#Lack of collaborated efforts and integration

Addressing the above mentioned issues has major significance in overall system for protection of children. Child protection is an issue that spreads across various departments and sectors including Health, Medical, Education, Police, Judiciary, Panchayati Raj, Railway, Transport etc. Strong allied system is the key feature for ensuring child protection and strengthening systems across the country.



Taking forward this initiative Child Resource Centre with the Department for Child Rights seeks to build strong collaboration with the other training institutions and structures working towards building capacities and technical expertise of various stakeholders and functionaries. In line with the same, CRC in collaboration with the Department for Child Rights, Rajasthan is planning to organize a series of training programmes for development of cadre of master trainers within different training institutions of the States including PRIs, Health, and Education. In this regards, a day long workshop was organized with the experts from different field

of child protection and representatives of the training institutions including State institute Of Educational Research and Training, Rajasthan (SIERT), State Institute

of Health & Family Welfare (SIHFW), Rajasthan, Indira Gandhi Panchayati Raj & Gramin Vikas Sansthan (IFPRS) etc. on 12th February, 2019 at HCM RIPA to brainstorm and conceptualize different training modules on related subjects, develop a pool of master trainers and mainstream child protection trainings in training curriculums of different training institutes.



BUILDING BRIDGES

NATIONAL CONFERENCE ON ROLE OF ACADEMIA IN CHILD RIGHTS

In partnership with UNICEF Rajasthan and Antakshari Foundation Child Resource Centre organized the Building Bridges: a two days National conference on Role of Academia in child Rights on 30th and 31st October, 2018. The consultation included participants from all the child rights centers across the country and representatives from NGOs, Government, training institutions as well as independent child rights experts. These institutions are primarily engaged in conducting research, advanced learning and advocacy to strengthen child rights laws, policies and practices in India. These Child Rights Centres are also providing technical support to different Government departments and statutory institutions for Knowledge Management, Human Resource Development and System Strengthening. Individually these Centres are doing a lot but collectively they have potential to bring desired changes in the lives of children. The objective of the conference was to increase collective learning through sharing of experiences, significant contribution in strengthening protection of children, and learning from the challenges faced by different centres etc. and Develop channels of knowledge exchange and experience sharing. It further aimed at improving collective action towards strengthening Child Protection system across the country through contribution in comprehensive research/ study, knowledge sharing and collective actions. For example these child rights centres may exchange research findings and information gathered through their projects, works and assignments with a view to develop a common resource pool. The common objective of upholding the interests of children makes it necessary for the Centres and the others to act jointly that give rise to a common voice. Collaborative efforts can be directed towards the study of legislations, rules etc. that impact child rights thereby avoiding duplication of work.

- #To map common areas of interest, capacities, resources and engagement.
- #Building a roadmap towards sustainability of Child Rights centres.

Identification of minimum deliverables of capacity building modules for various stakeholders

Documentation of lesson learnt, failures and best practices of various CRCs across the nation

#Syllabus of academic institutions housing CRCs should include Child Rights as part of the core curriculum.



CRC developed a detailed report of the conference and a Compendium which included details of Child Rights centre and their work.






